During 2020, WFF supported over 500 firefighters and their families.

4b (Code: ) (Expenses \$ 21,700 including grants of \$ ) (Revenue \$ ) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). WFF offices house a wildland firefighter museum, providing memorabilia, photographs and educational materials on display to the public. During 2020 WFF staff also traveled to a few locations to provide public education. (Note that the public education events for 2020 were reduced due to Covid-19.)
