4a (Code:) (Expenses \$ 712,991 including grants of \$ 214,591) (Revenue \$) ASSISTANCE TO FAMILIES OF FALLEN AND/OR INJURED WILDLAND FIREFIGHTERS: WFF provides direct grants and benevolent assistance to help injured firefighters and their families, as well as families of fallen firefighters, counseling assistance, travel for medical and funeral services, benevolent assistance for basic living needs in hardship cases, and Christmas assistance for the children through the Santa's Helpers program. During 2015, WFF supported 133 firefighters and their families. This included 14 firefighters supported through a donation given through another qualified 501(c)(3) organization providing direct support to firefighter families.

4b (Code:) (Expenses \$ 117,512 including grants of \$) (Revenue \$) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). WFF offices house a wildland firefighter museum, providing memorabilia, photographs and educational materials on display to the public. During 2015, WFF staff also travelled to 43 locations to provide public education.
