During 2016, WFF supported over 140 firefighters and their families.

4b (Code:) (Expenses \$ 219,824 including grants of \$) (Revenue \$) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). During 2016, WFF staff also travelled to numerous locations to provide public education.
