During 2017, WFF supported over 155 firefighters and their families.

4b (Code:) (Expenses \$ 65,420 including grants of \$) (Revenue \$) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). During 2017, WFF staff also travelled to numerous locations to provide public education.
