During 2018, WFF supported over 220 firefighters and their families.

4b (Code:) (Expenses \$ 58,107 including grants of \$) (Revenue \$) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). During 2018, WFF staff also travelled to numerous locations to provide public education.
