During 2022, WFF supported over 600 firefighters and their families.

4b (Code:) (Expenses \$ 377,499 including grants of \$) (Revenue \$) PUBLIC EDUCATION: WFF provides education to the public regarding the nature of wildfires and the dangers and the effects on the wildland firefighters (the men and women who put their lives on the line). WFF offices house a wildland firefighter museum, providing memorabilia, photographs and educational materials on display to the public. During 2022, WFF staff also traveled to a few locations to provide public education.
